Privacy Policy (website)

Protecting your private information is our priority. This Statement of Privacy applies to Our Lady of Fatima School and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Our Lady of Fatima School website is a news and information site. By using the Our Lady of Fatima School website, you consent to the data practices described in this statement.

Collection of your Personal Information

Our Lady of Fatima School may collect personally identifiable information, such as your name. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by Our Lady of Fatima School. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Our Lady of Fatima School website.

Use of your Personal Information

Our Lady of Fatima School may also use your personally identifiable information to inform you of other products or services available from Our Lady of Fatima School and its affiliates. Our Lady of Fatima School may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Our Lady of Fatima School does not sell, rent or lease its customer lists to third parties.

Our Lady of Fatima School may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Our Lady of Fatima School, and they are required to maintain the confidentiality of your information.

Our Lady of Fatima School may keep track of the websites and pages our users visit within Our Lady of Fatima School, in order to determine what Our Lady of Fatima School services are the most popular. This data is used to deliver customized content and advertising within Our Lady of Fatima School to customers whose behavior indicates that they are interested in a particular subject area.

Our Lady of Fatima School will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Our Lady of Fatima School or the site; (b) protect and defend the rights or property of Our Lady of Fatima School; and, (c) act under exigent circumstances to protect the personal safety of users of Our Lady of Fatima School, or the public.

Use of Cookies

The Our Lady of Fatima School website may use “cookies” to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Our Lady of Fatima School pages, or register with Our Lady of Fatima School site or services, a cookie helps Our Lady of Fatima School to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Our Lady of Fatima School website, the information you previously provided can be retrieved, so you can easily use the Our Lady of Fatima School features that you customized. You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer.
